<sup>1</sup> A domestic payment transaction is when the merchant and card issuer are located in the same country.  
<sup>2</sup> An Intra EEA payment transaction is when the merchant and card issuer are located in different countries, but both within the European Economic Area (EEA)  
<sup>3</sup> An Intra EU1 payment transaction is when the merchant and card issuer are located in different countries, where the issuer is located in the extended European Union (Andorra, the United Kingdom & Northern Ireland, Gibraltar, Monaco, San Marino, or Vatican City)  
<sup>4</sup> An Intra EU2 payment transaction is when the merchant and card issuer are located in different countries, where the issuer is located in the extended European Union (Israel or Turkey)  
<sup>5</sup> An interregional payment transaction is when the merchant and card issuer are located in different countries, where the issuer is located outside of the European Union.
